



Henkel Corporation, warrants its LePage® QUAD® Window and Door System against defects in materials for 15 years from the date of original installation by an LePage® QUAD® Window and Door System certified installer when the full LePage® QUAD® Window and Door System (LePage® QUAD® Max, LePage® QUAD® Foam and Henkel approved flashing tapes or membranes) is used to install windows and exterior doors, in the construction of new dwellings and additions to existing structures, in residential and light commercial buildings five (5) stories or less, in accordance with the recommended installation procedures of ASTM E-2112-07, AAMA 2400-10 standards and LePage® QUAD® Window and Door System specifications published by the Henkel Corporation. Standard manufacturer's warranties apply to the Henkel approved flashing tapes or membranes, these include: Protecto Wrap BT25XL, Protecto Flex, Protecto Shield, Protecto Super Stick Building Tape, DuPont™ Flashing Tape, DuPont™ StraightFlash™, DuPont™ FlexWrap™ NF, Grace Vycor® Plus, Grace Vycor® PRO, Grace Vycor® V40, Grace VYCORner®, Henry Blueskin® Butyl Flash, Kingspan – Pactiv Butyl Flashing. In the event of damage resulting solely from a defect in LePage® QUAD® Window and Door System materials Henkel Corporation will reimburse for the cost of the labor and materials to replace the defective materials, up to the value of \$10,000.00 per dwelling unit or addition.
