1.6 Usage

The Loctite EQ CL42 LED Dual controller is used with the EQ CL42 365nm and 405nm LED flood heads for use with light cure products that cure when exposed to ultraviolet and/or visible light. The system can be operated manually, operated with the integrated timer, or controlled with an external switch. The system is designed for intermittent or constant duty cycle.

2 Description

2.1 Theory of Operation

The EQ CL42 LED Flood Controller provides electrical power to the LED's through the connecting cable (not included).

Indicator lights located on the front panel of the power supply provide visual confirmation that the LED's are in or out of their acceptable range. In the event of temperature fault the power supply will automatically shut down to protect the LED array.

When the cure cycle is initiated, light is immediately irradiated at or near maximum intensity from the LED's.

The curing process begins when the adhesive is placed under the LED's. The two primary variables that control the curing process are the time of exposure and the strength of the light (irradiance). For a given irradiance, the exposure time required to fully cure the adhesive depends primarily on the properties of the adhesive and the optical properties of the substrate that the light is transmitted through.

4 Installation

Before using the equipment for the first time check it carefully for signs of external damage. If any shipping damage is found DO NOT USE THE EQUIPMENT – return it to your supplier immediately.

4.1 Environmental and Operating Conditions

- No direct sunlight.
- Recommend operating temperature; +10 ° C to +40 ° C (+50 ° F to +104 ° F)
- No splashing waters.
- No suddenly temperature changes, vibration and shocks.
- No high magnetic and intense electric.

4.2 Connecting the Unit

- Connect Sub D 9 pin connector of the footswitch 97201 or a higher-ranking controller to XS 1.
- Connect the 15 pin Sub D connector to the LED Head Array to XS 31~34.
- Connect power cord to the appropriate plug.

5 Operation

5.1 Electrical Connection

- Plug the female end of the LED power cable into the 15 pin D-sub connector located on the rear panel of the LED Array housing. Plug the male end into the 15 pin D-sub connector located on the rear panel of the controller. Make sure that the connections at both ends are secure.
- Plug the AC power cord into the back of the controller and connect to power source.
- For manual operation, plug the footswitch into the 9 pin D-sub connector marked XS1, located on the rear panel of the CL30 controller.

- For automated control, connect external PLC output relay to pins one and nine of XS1.

5.4 Parameter Setting Page



1. Running Mode selection: Continue, Timer or Advance

Continue Mode: The LED head will turn ON when a footswitch is pressed and remain ON until the footswitch is released. The intensity can be set up for each channel independently.

Timer Mode: The LED head will turn ON when a footswitch is pressed and remain ON for the duration that is set on the timer. If the time is set to 0 then when a footswitch is pressed the LED head will turn ON and remain ON until the Footswitch is pressed again. The intensity can be set up for each channel independently.

Advance Mode: This enables intensity to change automatically during the curing cycle.

- **2.** Link Button: The linked LED head will turn on with start signal.
- **3.** Restore factory setting.
- 4. Save Setting: Save changes.

5. Intensity & Timer setting. When clicked, can enter below page to set intensity and timer.

Continue Mode: Enter required intensity percentage setting (normal operation set 100%).



Timer Mode: Enter required intensity percentage setting (normal operation set 100%) and curing time required.



Advance Mode: Enter required intensity percentage setting (normal operation set 100%) and curing time required.

7 Troubleshooting

A Before proceeding with any repair or maintenance operation disconnect the tool from the main electricity supply.

Malfunction	Cause/Demonstration	Corrective Action
No display appears on the screen when turning on	Check that the main power cable is connected to an AC source.	Plug in power cable properly.
power supply	Check the fuse in power inlet.	Replace fuse.
	Check if selecting the target channel for the program.	Select the target channel when setting the program.
LED head does not irradiate	Check if the UV intensity level is set to 0% in the channel program.	If it is 0%, set the UV intensity level to 1% or higher.
Temperature warning	The channel connection indicator changes to orange when the LED head temperature has reached the warning level. If you continue the operation in this condition, the product life will be significantly shortened, and the temperature may exceed the upper limit 65°C, causing an emergency stop.	Set the UV intensity level(%) lower or improve the heat radiation performance of the LED head to keep the temperature lower than the warning level.
	Check if the fan on the LED head is working well.	Replace the fan, make sure there is good heat exhaust for LED head.
