APPLICATION FIELD

Removes wallpaper including washables, vinyls*, painted wallpapers and woodchip.

INSTRUCTIONS FOR USE

Preparation

- 1. Protect surrounding area and furniture with polythene sheeting
- 2. *Remove decorative face of vinyl wallpaper
- 3. Score face of wallpaper with wire brush or wallpaper scoring tool taking care not to damage the wall

INSTRUCTIONS FOR USE (cont.)

Application

1. To remove up to 40m² of wallpaper, mix as follows in a clean plastic bucket:

| Wallpaper type | Remover | Cold water | Mix ratio |
|---|-----------------------|------------|-----------|
| Standard wallpapers (including vinyls*) | 100ml (2.5 cap doses) | 4 litres | 1:40 |
| Painted and heavy wallpapers (including woodchip) | 200ml (5 cap doses) | 4 litres | 1:20 |

- 2. Apply a liberal, even coat over the wallpaper using a brush or sponge. Wipe off accidental splashes immediately with a damp cloth
- 3. Leave to soak 10 to 15 minutes
- 4. Scrape off softened wallpaper with a scraper
- 5. Repeat application for multi-layer and stubborn wallpaper
- 6. Wash down wall with detergent and water to remove traces of adhesive

Important:

Wear rubber gloves & safety goggles

Do not allow wallpaper stripper to come into contact with electrical fittings, furniture and painted surfaces

Do not allow wallpaper stripper to come into contact with electrical fittings, furniture and painted surfaces

Do not use in combination with a steam stripper
