Dear Valued Customer,

We appreciate your business and your inquiry with regard to Regulation (EU) No. 1907/2006 ("REACH") and the associated implications for product availability before and after May 31, 2018.

Since Henkel receives a large number of inquiries like the one from you, we decided to inform all of our customers by a general letter on the basis of our current knowledge about the future availability of products we supply to our customers.

Our Sales or Customer Service Team will be happy to forward this letter to you, should you wish to receive a copy of it.

In order to more specifically respond to your request, we would like to emphasize that Henkel's position is — with regard to most of the substances contained in our products — that of a so-called "downstream user" within the meaning of REACH. This means that Henkel is not manufacturing the substances itself but rather sourcing them from either raw material manufacturers or any other source providing this material to the market. Therefore, where this is the case, Henkel is not required to register the substances contained in its products according to REACH. However, in all other cases where Henkel is actually obliged to register the substances under REACH, we strive to take all necessary actions to ensure product availability in the market even beyond May 31, 2018. On this date, the last REACH transition period ends, meaning that all REACH registrations need to have been completed, or the respective substances can only be placed on the market in very limited volumes. Please also refer here to our general REACH letter.

Being a downstream user, Henkel needs to rely on its suppliers fulfilling all of their REACH responsibilities including registrations. Any notification about a supplier planning to discontinue a raw material is taken seriously and adequate solutions are worked out in each single case.
